

TERMS AND CONDITIONS

The undersigned hereinafter called the applicant hereby applies for membership and agrees to purchase electric energy from the MOUNTAIN PROVINCE ELECTRIC COOPERATIVE, INC. referred to as the “**COOPERATIVE**” and in consideration for the acceptance of this application for the following terms and conditions;

1. The **applicant** will pay to the **cooperative** the amount of Fifty Pesos (Php.50.00) which will constitute as the applicant’s membership fee upon acceptance by the **cooperative** of his/her application.
2. That when the electric energy becomes available, the **applicant** shall purchase from the **cooperative** all electric energy used in his/her premises and will pay the monthly rates to be determined from time to time in accordance with the by-laws of the **cooperative**.
3. The **applicant** shall cause/initiate the premises to be wired and to comply all requirements under the Phil. Electrical Code and as provided in the MOPRECO Board Policy on house wiring. (He/She shall allow/permit the MOPRECO Technical personnel or house wiring inspector to inspect the wiring installation from time to time or as the need arises).
4. The **applicant** shall comply with, and be bound with the provisions of the charter and by-laws of the **cooperative** or any amendments thereto.
5. The **applicant** after paying membership fee and becoming a member assumes no personal responsibility for any debts or liabilities of the **cooperative** and expressly understood that under the law, his private property is exempt from execution for any debts or liabilities of the **cooperative**.
6. The **applicant** will grant the **cooperative’s** request for any rights and easement to operate, replace and repair and perpetually maintain on the property owned by the **applicant** and or upon all roads, streets or highways abutting said property, its lines for the transmission or distribution of electric energy and will execute and deliver to the **cooperative** any conveyance, grant or instrument which the coop shall deem necessary or convenient for said purpose. All lines and other materials like switches, kwh meters and other appliances and equipment constructed or installed by the **cooperative** shall remain its sole responsibility and therefore have the right to access to said property, to operate, maintain or relocate its facilities.
7. The **cooperative** shall not be liable in any damages to the **applicant** for failure to supply electricity to said premises under any condition.
8. Any additional load without the knowledge of the **cooperative** that may cause hazards and damages will be the sole responsibility of the **applicant**.
9. The **applicant** undertakes to pay his/her outstanding electric bill/s and grant the **cooperative** the authority to **discontinue** providing electricity for **failure** to pay his/her bill/s and shall pay a reconnection fee before he/she will again enjoy the benefits and services of the **cooperative**. In the event, that the tenant vacated the house and did not pay his power bills, the owner of the house is responsible for paying whatever unpaid bills left by the tenants after issuing due notice.
10. The acceptance of this application by the **cooperative** shall constitute an agreement between the **applicant** and the **cooperative**.
